1. CONFLICT OF COMMITMENT TOOLKIT – OUTSIDE PROFESSIONAL ACTIVITIES (OPA)

To support compliance with Conflict of Commitment and Conflict of Interest in Research reporting requirements the Office of Academic Personnel in partnership with the Office of Research Compliance developed a toolkit of training material and resources. UC DAVIS HEALTH **Outside Professional Activities**

DEFINITION


- Any activities within your area of professional or academic expertise that are performed for a person or entity other than the University of California

REPORTING IS REQUIRED


- Reporting is required in OATS (Outside Activities Tracking System) and falls into three categories
- Best practice: report all outside professional activities regardless of category
- Applies to School of Medicine and School of Nursing faculty

CATEGORY 1 ACTIVITIES


- Require Prior Approval
- Include teaching outside of UCD, founding or investing in industry companies and outside faculty appointments

IMPORTANT TO REMEMBER


- Reasonable travel expenses are not required for reporting but should be tracked
- Annual pay thresholds:
 - \$40,000 or 40% base (X) salary at scale 0, whichever is greater
 - OR Department can opt for a lower threshold
- Annual time thresholds:
 - Limit of 21 days per year (168 hrs)
 - 22-48 days can be permitted with prior approval
- Report on a Fiscal Year basis
- Earning from outside activities include all forms of remuneration i.e., cash, stocks and stock options

CATEGORY 2 ACTIVITIES


- Do not require prior approval
- Include acting as an expert witness, consulting and speaking for industry

CATEGORY 3 ACTIVITIES


- Include speaking engagements and research for other academic institutions or non-profit organizations
- Do not require disclosure in annual reporting and do not require prior approval unless there is student involvement
